On September 27th, LawNY celebrated its 50th Anniversary with a dinner that brought together friends, alumni, staff, donors and community partners to reconnect and reminisce. We also listened to powerful testimonies from former clients that highlighted both the legal needs in our community as well as the positive impact of civil legal services. We were also honored that Tim Curtin from the Law Department of the City of Rochester provided a proclamation on behalf of Mayor Lovely Warren and the City of Rochester.
