

WHEREAS: With a three-year grant from the Greater Rochester Health Foundation, LawNY Rochester entered into a new project — Finger Lakes Legal Care. The grant allows LawNY Rochester to expand its medical-legal project with Rochester Regional Health (RRH); LawNY also established a Consumer Law Unit (CLU) in 2017 to assist individuals with consumer law problems — resolving 345 hotline issues in just over a year — avoiding or eliminating over \$60,000 in debt for clients; Another recent project is the IOLA Community Development and Economic Justice Project aimed at attacking the root causes of poverty; and

WHEREAS: One of the most impactful contributions to the Rochester community is the agency's residency in the Telesca Center For Justice, 1 West Main St., the building in which LawNY and three other legal aid service providers reside (Empire Justice Center, Legal Aid Society of Rochester and Volunteer Legal Services Project). The Telesca Center made Monroe County the first in the nation to integrate all legal services providers under one roof; and

WHEREAS: The services of LawNY over the years have been monumental to many of the residents in our community — to those who would otherwise find themselves incapable of securing adequate legal services and, thus, tossed into a state of chaos. LawNY often helps people through the crisis — helping to secure stability and safety after the emergency is resolved. The City of Rochester is most grateful for the professional help provided by the attorneys, paralegals and other dedicated staff of LawNY to our many residents in dire need.




