## HOUSING

We offer services to those at risk of losing their housing due to eviction or foreclosure. We also assist with housing discrimination complaints.

## PUBLIC BENEFITS

We can often assist with Social Security Benefits (SSI and SSDI), Supplemental Nutrition Assistance Program (SNAP), and Unemployment Benefit denials.

We offer services to assist with health insurance enrollment, issues with health insurance, and assist with managed care plans that cover long term care services, including home care services.

## HOW WE HELP

### 01 DIRECT LEGAL ADVOCACY

We meet with individuals to review their specific legal needs. This can sometimes involve going with you and advocating for you through fair hearings and court appearances. In 2025, we closed over 6,300 cases, benefiting over 13,500 individuals.

### 02 INFORMATION ABOUT RIGHTS

Sometimes individuals just need legal information on how to solve their legal issue rather than a fair hearing or court appearance. In 2025, we offered legal information to over 6,500 individuals through telephone consultations.

### 03 OUTREACH & EDUCATION

We work to continuously be out in the community educating individuals and community groups about their rights. In 2025, we attended over 800 outreach events, reaching over 37,000 individuals.

### 04 REFERRALS

LawNY® partners with several other human service organizations. If we cannot assist you, we will do our best to connect you with another organization that can.

## AGING

We often provide services to individuals over the age of 60 with long term planning such as creating wills, health care proxies, and more.

## DOMESTIC VIOLENCE

We offer holistic legal assistance to survivors of domestic violence and sexual assault with civil legal needs related to the abuse such as housing, restraining orders, and much more.
